In this course students will be studying different novels produced during the first half of 20th century between 1900 and 1950 that is the period of Modernism as a literary movement. The focus of the chosen novels for study here will be highlighting the enormous and rapid social changes as thematic issues by which this period is marked. Students in this course will as well be shown the transformations that occurred at the level of literary language and style and appearance of 'rebellious' literary forms by which novel in 20th century is marked.

2. Course Main Objective

The main objective of the course is to make students build an ability to critically read, analyze and interpret properly the concealed meanings in novels of 20th century with all the difficulties by which they are categorized especially the exotic style and form as attempts of innovations in literature.
